Privacy Policy

This privacy policy sets out how we use and protect any information that you give us when you use this website and our services.

Over the Top Imagery knows that you care how information about you is used and shared and we are committed to ensuring that your privacy is protected in accordance with this policy.

You should read this privacy policy carefully and in full before accepting any services provided by Over the Top Imagery. By reading the policy or continuing to use the online site or our services, you are accepting the practices as described in this Privacy Policy.

1) What Personal Information About Customers Does Over the Top Imagery Gather?

- When you purchase imagery, services or RPAS systems from us, as part of the buying and selling process, we collect personal information you give us such as your name, physical address, email address and contact phone numbers.
- When you browse our store, we also automatically receive your computer's internet protocol (IP) address in order to provide us with information that helps us learn about your browser and operating system.
- We may also collect the following information:
 - o name and job title
 - o contact information including email address
 - o demographic information such as postcode, preferences and interests
 - o other information relevant to customer surveys and/or offers

2) What we do with the information we gather:

- The information we gather helps us to understand your needs and helps provide you with a better service, and in particular for the following reasons:
 - Internal record keeping.
 - We may use the information to improve our products and services.
 - We may periodically send promotional emails about new products, special offers or other information which we think you may find interesting using the email address which you have provided.
 - From time to time, we may also use your information to contact you for market research purposes. We may contact you by email, phone, fax or mail. We may use the information to customise the website according to your interests.
- We receive and store the information you provide us electronically.

3) How Secure is your Information?

- We are committed to ensuring that your information is secure. In order to prevent unauthorised access or disclosure, we have put in place suitable physical, electronic and managerial procedures to safeguard and secure the information we collect online. We take reasonable precautions and follow industry best practices to make sure it is not inappropriately lost, misused, accessed, disclosed, altered or destroyed.
- We work to protect the security of your information during transmission and the information is encrypted using secure socket layer technology (SSL) and stored with a AES-256 encryption. Although no method of transmission over the Internet or electronic storage is 100% secure, we follow all PCI-DSS requirements and implement additional generally accepted industry standards.

4) Consent:

- 3.1) How do we receive your consent?
 - When you provide us with personal information to complete a transaction, verify your credit card, place an order, arrange for a delivery or return a purchase, it is implied that you consent to our collecting your information and using it for the reasons stated above.
 - If we ask for your personal information for a secondary reason, like marketing, we will either ask you directly for your expressed consent, or provide you with an opportunity to say no.
- 3.2) How do you withdraw your consent?

5) Disclosure

• We will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so or if you violate our Terms of Service.

6) Third-Party Services – Sharing of Information

- In general, the third-party providers used by us will only collect, use and disclose your information to the extent necessary to allow them to perform the services they provide to us.
- However, certain third-party service providers, such as payment gateways and other payment transaction processors, have their own privacy policies in respect to the information we are required to provide to them for your purchase-related transactions.
- For these providers, we recommend that you read their privacy policies so you can understand the manner in which your personal information will be handled by these providers.
